# Vision, Mission and Objectives

Vision is to make India a significant contributor in World Trade by 2020.

❖ Government aimed to increase India's exports of merchandise and services from USD 465.9 billion in 2013-14 to approximately USD 900 billion by 2019-20.

Raise India's share in world exports from 2 percent to 3.5 percent.

❖ Initiatives such as "Make in India", "Digital India" and "Skills India" to create an "Export Promotion Mission" to provide a stable and sustainable policy environment for foreign trade.

# Highlights of FTP 2015-20

# 1. Merchandize Exports from India Scheme (MEIS)

- Merger of FPS, FMS, MLFPS, Agri Infrastructure Incentive Scrip and VKGUY.
- 2% to 5% duty credit scrip on realized FOB value to be rewarded to notified goods exported to notified markets which is valid for 18 months.
- Scrips are issued by DGFT and can be used for payment of Customs Duty, Excise and taxes.
- Notified goods include agricultural and village industry products, ecofriendly and green products, labour intensive products, industrial products, hi-tech products, pharma products, leather goods, steel products, wooden products, etc.
- Notified markets involve 239 countries including Europe, Canada, Japan, South Korea, Taiwan, China, etc.

### 2. Service Exports India Scheme (SEIS)

- Applicable to Service Providers located in India.
- Rewards service providers of notified services being provided from India.
- 3% to 5% duty credit scrip on net foreign exchange earned.
- Service providers with minimum of US \$ 15,000 in preceding FY are eligible.

### 3. EPCG Scheme

- Allows import of capital goods for pre-production, production and postproduction at Zero customs duty.
- Includes Computer software systems, Spares, moulds, dies, jigs, fixtures, tools & refractories for initial lining and spare refractories, capital goods, etc.
- Subject to Export Obligation equal to 6 times of duty saved on capital goods, to be fulfilled in 6 years.

### 4. EOU/STP Scheme

- EOUs with turnover of minimum Rs. 10 Cr.
- Permitted to set up warehouses outside premises or near port of export.

### 5. Status Holders

• Export House, Star Export House, Trading Export House, Star Trading House and Premier House became One Star, Two Star, Three Star, Four Star and Five Star Export Houses.

### 6. Approved Exporter Scheme (Self – Certification)

- Self certification by Status Holders.
- Vision of qualifying for PTAs, FTAs, CECAs, CEPAs.
- Can self certify goods as per Industrial Entrepreneur Memorandum (IEM), Industrial Licence (IL), Letter of Intent (LOI).

### 7. Online Filing of Documents

### 8. E-Commerce Exports

- Consigned goods upto FOB Rs. 25,000 can avail benefits under FTP.
- Can be exported through Foreign Post Offices / Logistics Services.

### 9. Quality Complaints and Trade Disputes

- A new chapter been incorporated in new FTP.
- Committee on Quality Complaints and Trade Disputes to be set up to resolve disputes faster.

### 10. Duty Exemption (EPCG, Duty Free Tariff Preference, etc.)

### 11. Export of Defence Items

- India To Export \$2 Billion Worth Of Defence Equipments By 2019.
- Indian defence equipments buyers include Vietnam, Mauritius, Bangladesh, Oman and Afghanistan.
- The increase in defence exports from Rs 4,682 crore in 2017-18 to Rs 10,745 crore in 2018-19.



### **Prohibited Items**

Wild Animals, Exotic Birds, Wooden Logs, Timber, Pulp, Charcoal, Plants, Human Skeletons, Animal Fat, Chemicals, Sandalwood, Red Sanders



### **Restricted Items**

Sea Cucumbers, Cattle, Camel, Fertilizers, Fabrics with imprint of Verses of Holy Quran, Deoiled groundnut cakes, Silver Pomfrets, Fur of domestic animals, Fodder



### **Canalised Items**

Petroleum Products, Gum Karaya, Mica Waste and Scrap, Mineral Ores and Concentrates, Nigar Seeds, Bulk Agricultual items, Onions

# **Deemed Exports**

- Transactions where goods supplied do not leave the country and the payment for such supplies is received either in Indian rupees or in free foreign exchange.
- not done on a zero-rated basis.
- attract the IGST liability but input credit of IGST can be claimed.
- DBK can be claimed.
- can't be made with an LUT bond
- Supply of goods against Advanced Authorization
- Supply of goods to EOUs, SEZs, STPs, EHTPs.
- Supply of capital goods to licence holders under EPCG Scheme
- Supply of goods to projects financed by Agencies notified by MoF.
- Supply of goods to fertilizer plants during international competitve bidding.
- Supply of goods for powe, oil and gas projects notified by MoF.
- Supply of Marine Freight Containers
- Supply to UN funded projects
- Supply of goods to Nuclear Power Projects through competitve bidding.

# **Status Holders**

 All exporters of goods, services and technology having an import-export code (IEC) number shall be eligible for recognition as a status holder.

# Software Technology Parks

- 100% export oriented scheme for development and export of computer software using data communication or physical media.
- Includes export of professional sevices.
- Introduced in 1991 to boost software exports.
- Comprises mainly of software and business process outsourcing.
- An Indian Company or a Foreign Company is eligible to become a STP Unit only after applying for registration with STPI.
- Benefits Duty Free Imports, Import of Second Hand Capital Goods, Deemed Exports, Tax Holiday, Foreign Investment, Realisation of unutilised materials, Conversion to EOU, Single Window Clearance for Registration, Approvals, ITC, Green Card, Attestation of S/w Declarations, Conversion, Re-export, Exit.




# Electronic Hardware Technology Parks

- 100% export oriented scheme for electronic hardware equipment and component manufacturing in India.
- Can be set up by Central, State Govt, Public or Private undertakings.
- Capital goods can be imported outright, loan, free and lease.
- Benefits Duty Free Imports, Import of Second Hand Capital Goods,
  Deemed Exports, Tax Holiday, Foreign Investment, Realisation of
  unutilised materials, Conversion to EOU, Single Window Clearance for
  Registration, Approvals, ITC, Green Card, Attestation of S/w
  Declarations, Conversion, Re-export, Exit.

# **Bio Technology Parks**

- Specialised industrial parks in the field of biotechnology.
- Carries out related to genetic manipulation of microorganisms for the production of antibiotics, hormones, etc.
- Financial and Logistical support to new entrepreneurs with intellectual capabilities for innovation.
- Tamil Nadu, Telangana, Kerala, Karnataka, Maharashtra, UP, etc.
- Benefits Duty Free Imports, Import of Second Hand Capital Goods, Deemed Exports, Tax Holiday, Foreign Investment, Realisation of unutilised materials, Conversion to EOU, Single Window Clearance for Registration, Approvals, ITC, Green Card, Attestation of S/w Declarations, Conversion, Re-export, Exit.




# Integrated Industrial Areas

- An area where industry, residential and other facilities are integrated for increasing investment and employment generation.
- Land use of minimum 60:40 (Industrial:Residential)
- Maharashtra is in lead.
- Waiver of 50% Stamp Duty on the first agreement between promoter and buyer of the plot.
- 1% of Ready Reckoner Rate (Standard Value of an immovable property) is charged by MIDC which is further subject to 50% waiver.
- 54 SEZ may get converted into IIAs.
- Navi Mumbai SEZ to be converted to IIA by 2019 by the major promoter Reliance Industries Jai Corp and CIDCO with 15% for residential purpose with an opening of IT and IT enabled services.

# Special Economic Zones

- > A Duty Free Buisness Area
- > Different Trade Laws from the rest of the country
- Deemed to be a Foreign Territory
- > Located within a country's national borders
- Facilitates national trade balance, employment, investment, job creation and effective administration.
- Service, production, processing, assembling, trading, repair, remaking, reconditioning, re-engineering, making of gold / diamond jewellery.
- Allowed to manufacture items reserved for SSI's like pickles, chutneys, mustard oil, glass bangles, wax candles, steel chairs, laundry soap, stainless steel and aluminium utensils, etc.
- Covers Free Trade Zone (FTZ), Export Processing Zone (EPZ), Free Zones (FZ), Industrial Estates (IE), Free Ports, etc.







# Agriculture Export Zone

- Specific geographic location in a country.
- Set up of industries for agricultural processing, for export.
- 60 AEZs been sanctioned with 40 agricultural commodities in India.
